# HAGUE CONVENTION COUNTRIES

Originals and copies of international passports (valid for at least 6 months)

Certificate of Marital Status or Single status certificate with an apostille and a notarized translation in English (the validity period of the certificate is no more than 3 months)

Birth certificates with notarized English translation and apostille

Divorce certificates with notarized English translation

Copies of passports of witnesses



# ISRAELI CITIZENS

Originals and copies of international passports (valid for at least 3 months)\*

Tamtzit Rishum with notarized translation and apostille

\*The Municipality of Paralimni (Protaras) obliges Israeli citizens to also provide birth certificates with an apostille and English translation.



### LEBANESE CITIZENS

Originals and 2 copies of international passports (valid for at least 6 months)

Certificate of family composition: 1 original in Arabic + 1 notarized copy with English translation, certified by the MFA of Lebanon and the Embassy of Cyprus in Lebanon

Certificate of individual civil status: 1 original in Arabic + 1 notarized copy with English translation, certified by the Lebanese Ministry of Foreign Affairs and the Cypriot Embassy in Lebanon

Form of intent to marry signed by both spouses from the Lebanese Embassy in Cyprus

\*To legalize the marriage certificate, you will also need to issue a power of attorney to the company representative so that he can submit documents to the Lebanese Embassy after the ceremony without the presence of the couple.



# RESIDENTS **OF CYPRUS**\*

\*European citizen

Originals and copies of international passports (valid for at least 6 months)

Certificate of Marital Status or Single status certificate with an apostille and a notarized English translation (the validity period of the certificate is no more than 3 months)

Birth certificates with notarized English translation

Divorce certificates with notarized English translation

Affidavit from the Cyprus court stating that you are not currently married



# RESIDENTS **OF CYPRUS**<sup>\*</sup>

\*third country nationals



Originals and copies of international passports (valid for at least 6 months)

Certificate of Marital Status or Single status certificate with an apostille and a notarized English translation (the validity period of the certificate is no more than 3 months)

Birth certificates with notarized English translation

Divorce certificates with notarized English translation

Marriage license at the immigration office in Nicosia



# NON HAGUE MEMBERS

Originals and copies of international passports (valid for at least 6 months)

Certificate of Freedom (Certificate of Nom-Impediment to Marriage (CNI)), certified by the Ministry of Foreign Affairs with notarized translation into English and stamped by the Cyprus Embassy

Birth certificates, certified by the Ministry of Foreign Affairs with notarized translation into English and stamped by the Cyprus Embassy

Divorce certificates, certified by the Ministry of Foreign Affairs with notarized translation into English and stamped by the Cyprus Embassy

\*At the discretion of the municipality, additional legalization (stamp) may be requested from the Cyprus MFA

# IF YOU HAVE REFUGEE STATUS

Originals and copies of international passports (valid for at least 6 months)

Certificate of Marital Status or Single status certificatewith an apostille and a notarized translation into English (the validity period of the certificate is no more than 3 months)

Birth certificates with notarized translation into English

Divorce certificates with notarized translation into English

Copies of passports of witnesses

Marriage license at the immigration office in Nicosia

Asylum seekers paper

Document showing your legal visit to Cyprus



This list of documents is standard for registration in all municipalities of Cyprus. Also, any municipality has the right to request additional documents at its discretion, so it is important to provide scans of completed documents in advance.
